1 Important information

Your contract

Your Policy is a contract between You and Us and is made up of:

- Your Certificate of Insurance;
- this Product Disclosure Statement and Policy Booklet (PDS); and
- any applicable supplementary PDS.

More than one insured

If there is more than one insured, anything that any insured says, does or omits applies to all of the insureds. Each insured can act on behalf of all the insureds as their agent.

Certificate of Insurance

Your Certificate of Insurance shows the cover of Your insurance and any optional benefits You have added under Your Policy. It also shows the Period of Insurance Your Policy covers – We only cover You for incidents that happen during this time.

Receiving Your Policy documents

You may choose to receive Your Policy documents:

- electronically – that is, by email; or
- by post.

If We send Your Policy documents to You by email, We will send them to the person and email address You have nominated for receiving Policy documents. Any Policy documents We send to this email address will be considered to have been received by You 24 hours from when We send them.

If We send Your Policy documents to You by post, We will send them to the person and mailing address You have nominated for receiving Policy documents.

You are responsible for making sure the person and email or mailing address We have for Your Policy documents is up to date. So, You need to tell Us if this email or mailing address change – see 'Changes to Your Policy' in this section.

Limits, exclusions and conditions

Limits, exclusions and conditions apply to the cover You have chosen:

- throughout this PDS, We set out any specific limits, exclusions and conditions with the cover they apply to;
- We set out the general exclusions that apply to all covers and benefits under Your Policy in the 'General Exclusions' section; and
- We set out Your responsibilities when You are insured with Us in 'Your responsibilities' in this section.

Special conditions and embargoes

We may apply special conditions on Your Policy that may exclude, restrict or extend cover for a person or a particular matter at the time that You purchase the Policy. For example, We may not cover You for some incidents like a bushfire, storm or Flood if they cause loss or damage during a specific period which is also known as an embargo period.

Your current Certificate of Insurance shows any special conditions that apply to Your Policy, including the period of any applicable embargo.

In addition, We may apply special conditions during the Period of Insurance that limit Your ability to make changes to coverage, Sums Insured and Your Policy terms.

Your Premium

In return for paying Your Premium, We provide the cover You have chosen.

Paying Your Premium

You must pay Your Premium on time. You can pay Your Premium:

- annually in one lump sum; or
- in instalments by direct debit from an account or credit card You nominate (if We offer this option to You).

Your Certificate of Insurance shows the amount You need to pay and the due date for Your annual Premium or each instalment.

What happens if You don't pay on time

When You take out insurance, You need to pay Your annual Premium or any instalments by the due date specified on Your Certificate of Insurance.

An instalment is unpaid if it cannot be deducted from Your nominated account or credit card.

If Your Premium is overdue We will send You a notice outlining the overdue amount and when it needs to be paid.

If Your Premium remains unpaid after the time period specified in the notice We send, We will:

- cancel Your Policy for non-payment; and
- refuse to pay any claim for an incident occurring after the cancellation date.

If You pay by instalments, We will send You a second notice either before cancellation informing You of the effective date of cancellation, or within 14 days after cancellation confirming the effective date of cancellation.

If You need to make a claim when Your Policy is overdue, and before Your Policy has been cancelled for non-payment, We will require You to pay the overdue amount as part of the claim settlement process.

Excess(es)

An Excess is Your contribution towards the cost of a claim. The amount and types of Excess that applies to Your Policy will be shown on the Certificate of Insurance. Please see 'Excess' in the 'Claims' section for information on the type of Excess that may apply to Your claim and when You may not be required to pay an Excess.

Cooling-off rights

You can tell Us to cancel Your Policy within 21 days from:

- the date We issue Your Policy – for example, if You call Us on 3 May to set up a new Policy from 10 May, then Your 21 day cooling-off period starts from 3 May as that's when We issued Your Policy; and
- the start date of the Period of Insurance that applies when You renew Your Policy.

If You tell Us to cancel Your Policy within those times, We'll refund the Premium You paid Us in full. However, We will only do that if You haven't made a claim on Your Policy. You can also cancel Your Policy as set out in 'Cancellation' in this section.

Changes to Your Policy

You may want to make a change to Your Policy (for example, adding optional benefits to increase Your cover). To make a change to Your Policy please contact Us.

If We agree to make the change, We will:

- tell You if any additional Premium applies to the change and require You to pay this amount in order to make the change under Your Policy; or
- refund any amount We owe You due to the change; and
- issue You with a Certificate of Insurance.

If You change Your contact details (for example, the mailing or email address You have nominated to receive Policy documents) You must tell Us as soon as reasonably possible. If You don't, We will consider that You received Your Policy documents (that We sent to Your old address) even though You didn't. We will continue to send Your Policy documents to the mailing or email address You have nominated until You tell Us to update Your contact details.

Cancellation

In addition to Your 'Cooling-off rights', You may cancel Your Policy at any time (for example, if You no longer want Your Policy).

There may be circumstances where We need to cancel Your Policy. We will only do this if the law allows it.

If Your Policy is cancelled:

- We will refund a portion of Your Premium after We deduct an amount that covers the period that You have been insured for; or
- and You pay Your Premium by instalments, We will deduct any unpaid instalments that are due. You authorise Us to deduct any unpaid instalments by direct debit from the account or credit card You previously nominated for instalment deductions. As We are only allowed to deduct the agreed amount You previously authorised, We may need to collect the total amount You owe Us over a few instalments.

Renewal

At least 14 days prior to expiry of Your Policy We will give You notice in writing of the date and time of expiry and advise You if We are prepared to renew Your Policy. If We offer to renew Your Policy We will send You an updated Certificate of Insurance and quote a premium based on the information in Your current Policy. You should review any offer of renewal to ensure the insurance cover is still appropriate for You.

If You paid Your last Premium:

- as an annual Premium by direct debit, We will deduct the renewal Premium from the account or credit card You previously nominated; or
- by instalments, We will continue to deduct payments from the account or credit card You previously nominated for instalment deductions,

and Your Policy will automatically renew if We offer You a renewal. If You do not want Us to continue to deduct these payments and automatically renew Your Policy, please contact Us prior to expiry of Your Policy.

If You paid Your last Premium as an annual Premium without a direct debit arrangement, We must receive Your payment of the renewal Premium by the due date otherwise Your Policy will not renew.

Assigning rights and appointing a representative

Assigning Your rights

You must not assign any benefits, rights or obligations under Your Policy unless You get Our written consent first.

Appointing someone to represent You

If You want to appoint someone to represent You, then You need to tell Us and We need to agree that We will deal with them on Your behalf. We will not unreasonably withhold Our consent. For example, You may ask someone to manage Your Policy or a claim.

We may have a concern with a party that You may want to appoint if they present a conflict of interest, for example, someone who supplies goods or services for Your claim. We will not pay any costs charged by anyone You appoint to represent You.

Your responsibilities

When You take out a Policy with Us or make a claim, You have certain responsibilities that are set out in this section. These responsibilities also apply to any person that is covered by Your Policy. If You don't meet Your responsibilities, We may refuse to pay Your claim or reduce what We pay for Your claim. We may also decide to cancel Your Policy. The course of action We take when You fail to meet Your responsibilities will be considered in each circumstance based on what impact or effect Your failure caused or contributed to the claim or Our decision to issue Your Policy.

You must tell Us if:

- there is any change in Your circumstances during the Period of Insurance;
- there is any change to where Your Vehicle is usually kept;
- there is any change to the way Your Vehicle is used including but not limited to if You use Your Vehicle for business, rideshare, take away food delivery, courier or other deliveries, driving or riding instruction, farming activities, hire or rent, professional motor sports, taxi or people transportation or trade;
- there is any change to the regular drivers or riders of Your Vehicle;
- there is any change to the estimated kilometres Your Vehicle drives annually;
- You have fitted any Modifications to Your Vehicle that We asked You about when You first applied for Your Policy;
- any drivers or riders of Your Vehicle have been convicted of fraud; or
- any drivers or riders of Your Vehicle have had their licence disqualified, suspended or cancelled.

If You tell Us about any of these things, We may charge an additional Premium, change the cover of Your Policy, impose special conditions or cancel Your Policy to reflect the change in risk and terms upon which We have issued Your Policy. If You do not wish to accept Our terms, You can cancel Your Policy.

You must also:

- be truthful and frank in any statement You make in connection with Your Policy;
- not behave in a way that is improper, hostile, threatening, abusive or dangerous;
- pay Your Premium, including paying instalments, by the due date;
- ensure that if Your Vehicle is insured for Agreed Value, the Agreed Value includes any Modifications, options and Accessories;
- take reasonable precautions to avoid a claim being made;

- do everything reasonable to prevent further loss or damage to any property if an incident happens;
- take reasonable steps to ensure You or anyone acting on Your behalf obeys all relevant laws;
- not make a fraudulent claim under this Policy or any other insurance policy; and
- follow the conditions of this Policy.

There are also things You must and must not do if You make a claim under this Policy. These are set out in the 'Claims' section. If You breach any of the terms of this Policy We may refuse or reduce a claim, cancel Your Policy or do both.

The course of action We take when You breach any of the terms will be considered in each circumstance based on what impact or effect Your breach caused or contributed to the claim or Our decision to issue Your Policy.

Your privacy is important to Us

We value the privacy of personal information We collect about You.

We collect Your personal information directly from You and through others including those listed in Our Privacy Policy, such as Our related entities, agents and distributors.

How We use Your personal information

We and the parties listed in Our Privacy Policy will use Your personal information for the purposes it was collected for. Those purposes usually include to provide You with assistance, a product or service You requested and to deal with claims.

Your personal information may also be used for other purposes that are set out in Our Privacy Policy. You may choose to not give Us Your personal information. However, not giving Us Your personal information may affect Our ability to provide You with a product or service, including processing a claim.

Further information

We may disclose Your personal information to:

- Our related entities;
- Our service providers - which includes some service providers that may be based overseas; and
- other parties as set out in Our Privacy Policy.

Our Privacy Policy provides more information about how We collect, from whom We collect and how We hold, use and disclose Your personal information.

Our Privacy Policy also provides information about how You can:

- access Your personal information;
- ask Us to correct Your personal information; and
- complain about a breach of the privacy principles set out in the Privacy Act 1988 (Cth) and how We will deal with Your complaint.

Your consent

You agree to Us collecting, holding, using and disclosing Your personal information as set out in Our Privacy Policy when You:

- provide Us with Your personal information; and
- apply for, use or renew any of Our products or services.

The General Insurance Code of Practice (Code)

The purpose of the Code is to raise the standards of practice and service in the general insurance industry.

The objectives of the Code are:

- to commit Us to high standards of service;
- to promote better, more informed relations between Us and You;
- to maintain and promote trust and confidence in the general insurance industry;
- to provide fair and effective mechanisms for resolving complaints You make about Us; and
- to promote continuous improvement of the general insurance industry through education and training.

The Code Governance Committee is an independent body that monitors and enforces insurers' compliance with the Code.

We have adopted and support the Code and are committed to complying with it. Please contact Us if You would like more information about the Code or Code Governance Committee.

Financial Claims Scheme

You may be entitled to payment under the financial claims scheme in the event that We become insolvent. Access to the scheme is subject to eligibility criteria. Information about the scheme can be obtained from www.fcs.gov.au.

Governing law, currency and GST

Governing law

This contract is governed by the law of the Australian State or Territory where the property insured under this Policy is kept.

Currency

All dollar values described in Your Policy are a reference to the lawful currency of Australia.

GST

All dollar values described in Your Policy include GST, unless We say they don't. If You are a business registered or required to be registered for GST purposes, then You must tell Us:

- Your Australian Business Number (ABN); and
- the percentage of any input tax credit You have claimed or are entitled to claim on the Premium.

2 Definitions

The following words have the following special meaning in this Policy when the words are capitalised. A reference to the singular includes the plural and vice versa, unless the context otherwise requires.

Accessory means an alteration or addition that is fitted to or permanently stored in a vehicle that is not directly related to its function as a vehicle but does not include any mobile or other telephone, laptop computer or tablet device.

Accident or **Accidental** means a sudden, unexpected and unintended event which was not intended or expected by You or anyone else insured under this Policy.

Act of Terrorism means any act which may involve the use of, or threat of, force, violence or biological or chemical warfare, or nuclear pollution or contamination or explosion where the purpose of the act is to further a political, religious, ideological aim or to intimidate or influence a government or any section of the public.

Agreed Value means the amount We agree to insure Your Vehicle for that is shown on Your Certificate of Insurance. It includes:

- any Modifications, options or Accessories to Your Vehicle;
- GST;
- registration and any compulsory third party insurance; and
- other on-road costs.

It does not include any:

- allowance for dealer profit;
- warranty costs;
- stamp duty; or
- transfer fees.

Authorised Driver means any person listed on the Certificate of Insurance as a driver or rider of Your Vehicle or any person who is driving, riding or in charge of Your Vehicle with Your permission.

Certificate of Insurance means the document outlining the details of Your insurance cover.

Club Plate Registration means a club or other designated special limited use registration of Your Vehicle granted by a relevant statutory body.

Communicable Disease means any disease which can be transmitted by means of any substance or agent from any organism to another organism where:

- the substance or agent includes, but is not limited to, a virus, bacterium, parasite or other organism or any variation thereof, whether deemed living or not; and
- the method of transmission, whether direct or indirect, includes but is not limited to, airborne transmission, bodily fluid transmission, transmission from or to any surface or object, solid, liquid or gas between organisms; and
- the disease, substance or agent can cause or threaten bodily injury, illness, emotional distress or damage to human health or human welfare or can cause or threaten damage to, deterioration of, loss of value of, marketability of or loss of use of property.

Excess means the amount(s) You must contribute to the cost of a claim. The amount and types of Excess that apply to Your Policy will be shown on Your Certificate of Insurance.

Flood means the covering of normally dry land by water that has escaped or been released from the normal confines of any of the following:

- a lake (whether or not it has been altered or modified);
- a river (whether or not it has been altered or modified);
- a creek (whether or not it has been altered or modified);
- another natural watercourse (whether or not it has been altered or modified);
- a reservoir;
- a canal; or
- a dam.

Genuine Parts means parts which were made by:

- the original manufacturer of Your Vehicle; or
- a supplier who provides parts to the original manufacturer of Your Vehicle.

Lay Up Period means the lay up period (if any) shown on Your Certificate of Insurance.

Liability Limit means the maximum amount of \$20,000,000 (inclusive of GST and all legal costs) We will pay for any one incident under the 'Cover for liability' section.

Market Value means Our assessment of the value of the vehicle immediately prior to the incident You are claiming for (or at the time of any claim under the 'Lifetime repair guarantee' additional benefit) using local market prices and considering the age and condition of the vehicle. It includes:

- any Modifications, options or Accessories to the vehicle;
- GST;
- registration and any compulsory third party insurance; and
- other on-road costs.

It does not include any:

- allowance for dealer profit;
- warranty costs;
- stamp duty; or
- transfer fees.

Modification means an alteration or addition to a vehicle that differs from the vehicle manufacturer's original specification or recommendation for the vehicle and which enhances (or is intended to enhance) the performance, or alters (or is intended to alter) the safety or handling, of the vehicle.

Period of Insurance means the period that is covered by Your Policy that is shown on the Certificate of Insurance.

Policy means the contract between You and Us and includes this document, any applicable supplementary PDS(s) and the Certificate of Insurance.

Premium means the total amount You pay for this Policy that is shown on the Certificate of Insurance. It includes government taxes such as GST and any other duties or charges that apply. If You pay Your Premium by instalments, Your Premium is the total of the instalments You need to pay over the Period of Insurance.

Protective Clothing means clothing designed to protect the rider of a motorcycle, including protective jackets, trousers, boots and gloves. Protective Clothing does not include helmets.

Substitute Vehicle means a vehicle that You do not own that has been borrowed or hired because Your Vehicle is being repaired, serviced or has broken down but does not include a hire vehicle rented from a commercial rental company.

Sum Insured means the Agreed Value of Your Vehicle as shown on the Certificate of Insurance. It is the maximum amount We will pay for loss or damage to Your Vehicle under 'Cover for loss or damage to Your Vehicle'.

Total Loss means when We decide to pay You the Sum Insured for Your Vehicle. This is usually where We decide that it is uneconomical to repair Your Vehicle or Your Vehicle has been stolen and not recovered.

Vehicle means the vehicle shown on Your Certificate of Insurance and includes any standard equipment that comes with it and any Modifications, options or Accessories.

It does not include:



- fuel or lubricants; or
- baby capsules or child seats.

We, Us and **Our** means the product issuer Insurance Australia Limited ABN 11 000 016 722 AFSL 227681 trading as NRMA Insurance.

You and **Your** means all the people named as the insured on the Certificate of Insurance.

3 Cover for loss or damage to Your Vehicle

You have cover under this section if Your Vehicle is a:

-  **car; or**
-  **motorcycle.**

What We cover

We will cover Your Vehicle for loss or damage occurring during the Period of Insurance caused by Accident within Australia. This includes loss or damage caused by:

- collision or crash;
- earthquake;
- explosion;
- fire;
- Flood;
- storm;
- theft or attempted theft;
- tsunami; or
- vandalism or a malicious act.

If Your claim is for theft or attempted theft, vandalism or malicious act, You must report the theft, attempted theft, vandalism or malicious act to the police and provide Us with the incident number and details of when and where the report was made.



What We don't cover

Under this 'Cover for loss or damage to Your Vehicle' We do not cover any:

- loss or damage from theft or attempted theft, vandalism or malicious act by You or with Your express or implied consent.
- loss or damage to any Substitute Vehicle.

4 Cover for liability

You have cover under this section if Your Vehicle is a:

-  **car; or**
-  **motorcycle.**

What We cover

We will cover the following people for the amounts they are legally liable to pay for loss or damage to another person's property within Australia during the Period of Insurance caused by use of Your Vehicle or a Substitute Vehicle:

- You;
- an Authorised Driver;
- a passenger for their legal liability arising from:
 - if Your Vehicle is a car - getting in or out or being in Your Vehicle; or
 - if Your Vehicle is a motorcycle - getting on or off or being on Your Vehicle; and
- Your employer, principal or business partner for their legal liability as Your employer, principal or business partner.

We will also cover the legal liability for loss or damage to another person's property within Australia during the Period of Insurance caused by a trailer, or by a caravan if Your Vehicle is a car, while being towed by Your Vehicle or a Substitute Vehicle but only if:

- the towing of the trailer or caravan is not for financial reward or payment; and
- Your Vehicle or the Substitute Vehicle is designed, suitably modified and compliant with all relevant legal requirements for the towing of the trailer or caravan.

We will also pay all legal costs and expenses incurred with Our prior written consent if We accept a claim under this 'Cover for liability'.

We will also cover You for general average or salvage which You are charged for a loss occurring during the Period of Insurance in relation to a ship transporting Your Vehicle by sea within Australian territorial waters.

We will provide cover up to a maximum of \$20,000,000 (inclusive of GST and all legal costs) (the Liability Limit) for any one incident.

What We don't cover

Under this 'Cover for liability' We do not cover any:

- claim for death or bodily injury.
- loss or damage to any Substitute Vehicle.
- claims by:
 - You;
 - Your relative, spouse, de facto or any person ordinarily residing with You or any other person with whom You ordinarily reside; or
 - any person covered under this 'Cover for liability'.
- loss or damage to any property owned or in the physical or legal control of:
 - You;
 - any person using Your Vehicle or a Substitute Vehicle; or
 - any person covered under this 'Cover for liability',but We will pay claims for loss or damage to a residential building that is rented and occupied by any of these people.
- claims where there is insurance required by law that provides cover for the liability or such insurance was available but was not taken out.
- penalties, fines or awards of aggravated, exemplary or punitive damages made against You or any person covered under this 'Cover for liability'.
- disease that is transmitted by:
 - You;
 - Your relative, spouse or de facto or any person ordinarily residing with You or any person with whom You ordinarily reside; or
 - any person covered under this 'Cover for liability'.
- legal costs and expenses that relate to a liability not covered by this Policy.
- legal costs and expenses We have not agreed to in writing.
- legal costs and expenses to defend any type of criminal proceeding or any fines or other penalties including but not limited to criminal offences or penalties involving the use of Your Vehicle or Substitute Vehicle or breaches of any road traffic legislation, by-laws or regulations.
- liability in connection with any seepage, pollution or contamination (including the cost of cleaning up) unless it occurs during the Period of Insurance and is caused by a sudden and Accidental event that occurs during the Period of Insurance.
- liability in connection with the ownership, use or maintenance of any vehicle within the restricted area of any airport.

5 Additional benefits

The additional benefits provided under this section depend on whether Your Vehicle is a:

 **car; or**

 **motorcycle.**

The Excess applies to the additional benefits unless otherwise stated.

These additional benefits are payable in addition to the Sum Insured for Your Vehicle or Liability Limit (as applicable) unless stated otherwise.

Baby capsules and child seats

Available if Your Vehicle is a:

 **car.**

If baby capsules or child seats suffer loss or damage while in, or are stolen from, Your Vehicle as part of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the replacement cost for the baby capsules or child seats.

Emergency repairs

Available if Your Vehicle is a:

 **car; or**

 **motorcycle.**

If Your Vehicle requires emergency repairs to be secured, driven or used as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the reasonable costs of the emergency repairs up to a maximum of \$1,000.

This additional benefit is included in the Sum Insured for Your Vehicle.

Under this additional benefit:

- We will determine what is an emergency repair;
- the emergency repairs must be made to keep Your Vehicle secure or to allow Your Vehicle to be driven or used; and
- You may pay for the emergency repairs up front and provide Us with a tax invoice.

We will not cover any:

- non-emergency repairs; or
- repairs that are caused by lack of maintenance or normal wear and tear.

Emergency transport and accommodation

Available if Your Vehicle is a:



If Your Vehicle is damaged and cannot be driven or used as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle' that occurs more than 100 kilometres from Your home, We will pay the reasonable costs of:

- transportation for You, Your passengers and Your domestic pets to Your home or, if We agree, to another destination;
- temporary accommodation for You, Your passengers and Your domestic pets covering the room rate only; and
- transportation of Your Vehicle from:
 - the place Your Vehicle is repaired to Your home; or
 - the location of the incident to a repairer near Your home.

We will cover You up to a maximum of \$1,500.

We must agree to the costs before they are incurred.

We will not cover the costs of transportation of any vehicle or other item being towed by Your Vehicle.

Excess free glass extension

Available if Your Vehicle is a:



If the windscreen, window glass, sun roof or moonroof of Your Vehicle is damaged during the Period of Insurance by Accident and there is no other damage to Your Vehicle, We will pay the costs to repair or replace the windscreen, window glass, sun roof or moonroof (including any window tinting, demisters or rain sensors) without requiring payment of the Excess.

This additional benefit is included in the Sum Insured for Your Vehicle.

You are only entitled to cover under this additional benefit if:

- the damage to the windscreen, window glass, sun roof or moonroof is the only damage to Your Vehicle; and
- You contact Us prior to any repair or replacement work and allow Us to arrange the repair or replacement through a repairer.

We will not cover any damage to mirrors, camera lenses or driving lights.

We may use parts that are not Genuine Parts to replace Your windscreen, window glass, sun roof or moonroof.

Fire extinguisher replacement

Available if Your Vehicle is a:



If Your Vehicle has a domestic fire extinguisher fitted or kept within it that is used during the Period of Insurance to:

- extinguish a fire in or around Your Vehicle, another vehicle or other property; or
- rescue or assist rescuing a person from a vehicle Accident,

We will pay the reasonable costs to replace, refill or replenish the fire extinguisher without requiring payment of the Excess.

We will only pay under this additional benefit once in any Period of Insurance.

We will not cover:

- commercial grade fire extinguishers; or
- any fire extinguisher that:
 - You use, or are required to have, as part of any business or profession;
 - You have an obligation to replace under any commercial maintenance program; or
 - has passed its expiry date at the time of its use.

Helmet cover

Available if Your Vehicle is a:



If during the Period of Insurance as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle':

- Your helmet is stolen from Your Vehicle while it was securely stored on Your Vehicle; or
- Your helmet is visibly damaged, or We agree the safety of Your helmet is compromised,

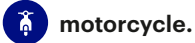
We will replace Your helmet with a helmet that is of the same or a similar type to Your helmet.

You must report any theft of Your helmet to the police and provide Us with the incident number and details of when and where the report was made.

If We replace Your helmet under this additional benefit, any salvage of Your helmet will become Our property unless We let You keep it.

Incorrect fuel

Available if Your Vehicle is a:



If You Accidentally put:

- fuel; or
- additives into fuel that You put,

in Your Vehicle that is incompatible with the engine type of Your Vehicle during the Period of Insurance, We will pay the reasonable cost to remove the incompatible fuel or additives from Your Vehicle and cover any loss or damage to Your Vehicle caused by the incompatible fuel or additives.

This additional benefit is included in the Sum Insured for Your Vehicle.

You must stop driving or riding Your Vehicle and advise Us as soon as reasonably possible after You become aware that the incompatible fuel or additive has been used in Your Vehicle.

We will not cover:

- any intentional or deliberate use of incompatible fuel or additives by You, any Authorised Driver or anyone acting with the express or implied consent of You or any Authorised Driver, including any costs to remove such fuel or additives, or loss or damage to Your Vehicle caused by such fuel or additives; or
- gradual damage or build up caused by use of incorrect octane of fuel in Your Vehicle.

Legal representation at coronial inquiry

Available if Your Vehicle is a:



If You or an Authorised Driver require legal representation before a coronial inquiry in relation to an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the legal costs of You or the Authorised Driver to be represented up to a maximum of \$10,000.

We will only cover legal costs that We have agreed to cover before they are incurred.

We will not cover any legal costs:

- relating to penalties, fines or awards of aggravated, exemplary or punitive damages; or
- for incidents where You or the Authorised Driver have been charged with any offence in relation to the incident including but not limited to offences for speeding, driving or riding with a blood alcohol level higher than the level allowed by law, driving or riding under the influence of alcohol or drugs or any deliberate or intentional actions.

Lifetime repair guarantee

Available if Your Vehicle is a:



If We authorise and pay for a repairer to repair Your Vehicle in relation to an incident We have agreed to cover under this Policy, We will provide a lifetime guarantee for the workmanship of those repairs as long as You are the owner of Your Vehicle.

Under this additional benefit:

- You must allow Us to inspect Your Vehicle at any reasonable time or place before any repairs;
- We decide how to fix any fault caused by poor workmanship; and
- We can choose to settle a claim through any of the following ways:
 - We can arrange for the original repairer or another repairer to repair Your Vehicle;
 - We can choose to pay You the reasonable cost to repair Your Vehicle as determined by Us. We determine what the reasonable cost is to repair Your Vehicle by looking at a range of factors including quotes from the original repairer or another repairer, Our nominated repair methods for the type of damage to Your Vehicle and reports from Our assessors; and/or
 - We can choose to pay You an amount that is equal to the Market Value of Your Vehicle at the time of the claim under this additional benefit.

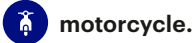
Our choice will have regard to the circumstances of Your claim and consider any preference You may have.

We will not provide any cover if:

- You have sold Your Vehicle;
- You (or anyone on Your behalf) authorised repairs to Your Vehicle without Our prior written agreement;
- You arrange repairs after We cash settle Your claim; or
- there is deterioration or wear and tear caused:
 - over time;
 - by use of Your Vehicle;
 - by exposing Your Vehicle to the elements; or
 - by Your failure to maintain Your Vehicle in good order and repair.

Methamphetamine contamination

Available if Your Vehicle is a:



If Your Vehicle is stolen during the Period of Insurance and recovered with Contamination Damage, We will pay the reasonable costs to Remediate the Contamination Damage within or to Your Vehicle to a level of 0.5 micrograms (μg) per 100cm² or less (or to the level specified by any relevant State, Territory or Commonwealth legislation as an acceptable level of surface presence of Methamphetamine in a vehicle or domestic premises if there is such legislation).

This additional benefit is included in the Sum Insured for Your Vehicle.

Under this additional benefit only, the following words have the meaning set out below when capitalised:

- "Contamination Damage" means surface contamination within Your Vehicle caused by Methamphetamine smoking or manufacturing that exceeds a level of 0.5 micrograms (μg) per 100cm² (or the level specified by any relevant State, Territory or Commonwealth legislation as an unacceptable level of surface presence of Methamphetamine in a vehicle or domestic premises if there is such legislation).
- "Methamphetamine" means the controlled drug methamphetamine as defined in the Criminal Code Act 1995 (Cth) or similar or replacement legislation or regulations.
- "Remediate" means to reduce the level of Contamination Damage.

Personal items

Available if Your Vehicle is a:



If personal items are:

- damaged in an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle'; or
- either:
 - if Your Vehicle is a car - stolen from Your Vehicle during the Period of Insurance; or
 - if Your Vehicle is a motorcycle - stolen from a locked compartment of Your Vehicle during an attempted theft We have agreed to cover under 'Cover for loss or damage to Your Vehicle',

We will pay the reasonable costs to repair or replace the personal items up to a maximum of \$1,000.

You must report any theft to the police and provide Us with the incident number and details of when and where the report was made.

We will not cover:

- helmets (note: the 'Helmet cover' additional benefit may apply - refer to that section);
- any loss of, or damage to, Protective Clothing that You have claimed for under the 'Protective Clothing' optional benefit;
- money, cheques, financial transaction cards or negotiable instruments;
- property used for earning an income;
- baby capsules or child seats;
- mobile telephones, laptops or any electronic items; or
- any Modifications, options or Accessories.

Replacement of keys and locks

Available if Your Vehicle is a:



If the keys or access codes to Your Vehicle are stolen, lost or duplicated or it is reasonable for You to believe that the keys or access codes to Your Vehicle have been stolen, lost or duplicated during the Period of Insurance and there is no other damage to Your Vehicle, We will pay the reasonable costs to repair, replace and recode the keys, locks, barrels, fobs or keypads up to maximum of \$2,000.

You may report the theft or suspected theft to the police and provide Us with the incident number and details of when and where the report was made.

Spare parts

Available if Your Vehicle is a:



If there is Accidental loss or damage to spare parts You own which are not attached to Your Vehicle but belong to, or could be used for, Your Vehicle that occurs within Australia during the Period of Insurance and the loss or damage either:

- occurs while the spare parts are being transported by You from the place You purchased them to the address where Your Vehicle is kept overnight as shown on Your Certificate of Insurance; or
- occurs at the address where Your Vehicle is kept overnight as shown on Your Certificate of Insurance and is caused by:
 - fire, lightning or explosion;
 - storm or Flood;

- theft or attempted theft following forceful entry into a locked building;
- vandalism or a malicious act; or
- earthquake, volcanic eruption, geothermal activity, landslip or tsunami,

We will pay the reasonable costs to repair or replace the spare parts up to a maximum of \$2,000 or, if You have chosen to increase Your cover for spare parts, up to the spare parts limit stated on Your Certificate of Insurance.

If Your claim is for theft, attempted theft, vandalism or a malicious act, You must report the theft, attempted theft, vandalism or malicious act to the police and provide Us with the incident number and details of when and where the report was made.

Taxi fare

Available if Your Vehicle is a:



car; or



motorcycle.

If Your Vehicle is being repaired as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will reimburse You for the taxi fares or rideshare service fees You incur:

- from the scene of the incident;
- to and from a hire vehicle provider that is to provide a vehicle for Your use during the repairs but only if We authorise the repairs; and
- to and from the repairer that is performing the repairs to Your Vehicle but only if We authorise the repairs.

We will pay a maximum of \$250.

You may pay for the taxi or rideshare service fees upfront and provide Us with a tax invoice or receipt for the fare or fee and We will reimburse You.

Temporary cover for a replacement vehicle

Available if Your Vehicle is a:



car; or



motorcycle.

If You replace Your Vehicle with another vehicle within 30 days of selling Your Vehicle during the Period of Insurance, We will cover the replacement vehicle on the terms set out in this Policy for a period of 14 days commencing on the date of purchase of the replacement vehicle.

If You wish to continue cover for the replacement vehicle after the 14 day cover period:

- You must contact Us within the 14 day cover period;
- You must provide Us with full details of the replacement vehicle necessary to apply for cover;

- We must agree to insure the replacement vehicle; and
- You must pay any additional Premium that is payable to cover the replacement vehicle.

If We agree to provide cover for the replacement vehicle after the 14 day cover period, We will issue You with a new Certificate of Insurance.

Towing

Available if Your Vehicle is a:



car; or



motorcycle.

If Your Vehicle is damaged and cannot be driven or used as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the cost of towing Your Vehicle from the scene of the incident to:

- a repairer or other place We recommend; or
- a safe place.

The cover under this additional benefit will also include the cost of towing Your Vehicle:

- between repairers; and
- to and from a storage facility or holding yard if storage is required before repair of Your Vehicle.

We will only pay under this additional benefit if We agree to pay the costs of the towing before they are incurred.

We will not cover any costs of towing Your Vehicle that You have claimed for under the 'Vehicle pick-up and return' additional benefit.

Trailer or caravan attached to Your Vehicle

Available if Your Vehicle is a:



car; or



motorcycle.

If a trailer or caravan attached to or being towed by Your Vehicle suffers loss or damage in an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay You:

- the reasonable cost to repair the trailer or caravan; or
- the Market Value of the trailer or caravan.

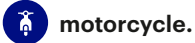
We will pay a maximum of \$1,500.

We will not cover:

- any contents of the trailer or caravan; or
- any caravan attached to or being towed by Your Vehicle if Your Vehicle is a motorcycle.

Vehicle pick-up and return

Available if Your Vehicle is a:



If Your Vehicle suffers loss or damage as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the reasonable costs of moving Your Vehicle:

- to a repairer from the scene of the incident; or
- from Your home or work to a repairer (and back again),

so the repairs required as a result of the incident We have agreed to cover can be completed.

We will decide how, and arrange, to move Your Vehicle. We will consider the circumstances of Your claim and any preference You may have.

We will not cover any costs of moving Your Vehicle:

- between repairers if You change Your mind about which repairer will conduct the repairs; or
- that You have claimed for under the 'Towing' additional benefit.

Vehicle storage costs

Available if Your Vehicle is a:



If Your Vehicle suffers loss or damage as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle' We will pay the reasonable costs to store Your Vehicle at a storage facility or holding yard from the time the claim is lodged until the earlier of when:

- Your Vehicle is sent to a repairer to complete the repairs; or
- We settle Your claim.

We will also pay the costs of:

- moving Your Vehicle to and from the storage facility or holding yard and the repairer; and
- storing and moving a trailer or caravan that was attached to or being towed by Your Vehicle at the time of the incident but only if We have agreed to cover a claim under the 'Trailer or caravan attached to Your Vehicle' additional benefit for loss or damage to the trailer or caravan from the incident.

Under this additional benefit:

- We must agree to pay the storage costs and moving costs before You make any arrangements;
- You need to move Your Vehicle if We ask You to; and
- We can move Your Vehicle if We need to.

6 Optional benefits

You may be able to add the following optional benefits to Your Policy if You apply for them and pay any additional Premium that applies. Whether You are entitled to add the optional benefits to Your Policy and the amount and extent of cover under the optional benefits may vary depending on the type of cover You have.

If We agree to provide any of these optional benefits with Your Policy, the optional benefit will be shown on Your Certificate of Insurance as added to the Policy. You are only entitled to those optional benefits that You have specifically chosen, paid any applicable additional Premium for and are shown on Your Certificate of Insurance as added to the Policy.

Hire vehicle or alternative transport after incident

Available if Your Vehicle is a:



If Your Vehicle is not drivable, unsafe to drive or being repaired as a result of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the reasonable costs for You to:

- hire a replacement vehicle; or
- use alternative transport of taxis, rideshare services or public transport,

from the date of the incident until the earliest of:

- the date Your Vehicle is recovered and any damage to it is repaired; or
- when We settle Your claim.

We will pay a maximum of \$100 per day for:

- hire of a replacement vehicle and a maximum of \$3,000 for any bond and excess payable under the hire agreement because there is loss or damage to the hire vehicle; or
- use of alternative transport.

We:

- only cover hire vehicle or alternative transport costs if Your Vehicle is not drivable, unsafe to drive or being repaired;
- will only cover costs of use of alternative transport where You provide Us with tax invoices and receipts for the transport;
- will only cover either the cost to hire a replacement vehicle or the cost to use alternative transport – We will not pay both;

- will arrange the hire of the replacement vehicle if You take this option and We will arrange the hire through one of Our preferred suppliers. You must not arrange Your own hire vehicle under any circumstances unless You obtain Our prior written consent. If You do arrange Your own hire vehicle without Our consent We may decide not to pay for this vehicle;
- will, if there is loss or damage to the hire vehicle, pay any difference between what You are covered for under the insurance for the hire vehicle and what You would be covered for under 'Cover for loss or damage to Your Vehicle' if the loss or damage had been to Your Vehicle; and
- may require You to refund to Us any costs We incur for a hire vehicle or use of alternative transport if You withdraw Your claim or We refuse to accept Your claim.

We will not cover:

- running costs for the hire vehicle (for example, petrol or tolls);
- any additional hire vehicle costs (for example, optional extras such as a GPS);
- loss or damage to the hire vehicle;
- liability which results from using the hire vehicle; or
- any additional hire vehicle costs if repairs to Your Vehicle are unreasonably delayed by You or a repairer appointed or engaged by You.

Lay up cover

Available if Your Vehicle is a:



car; or



motorcycle.

If You have added this optional benefit to Your Policy:

- Your Premium for the Period of Insurance may be lower than it would have been if You had not selected this optional benefit – Your Premium is shown on Your Certificate of Insurance. Contact Us if You have questions about Your Premium; and
- in the Lay Up Period, We will not cover:
 - You; or
 - any person covered under this Policy,

under any section of this Policy unless an incident or Accident otherwise covered by this Policy occurs when Your Vehicle is:

- stored in the place Your Vehicle is usually parked as shown on Your Certificate of Insurance at the address where Your Vehicle is kept overnight as shown on Your Certificate of Insurance;
- being taken to or from a repairer or mechanic for a scheduled service or to be repaired; or
- at a mechanic for restoration, but only if the 'Restoration benefit – off road' optional benefit is shown on Your Certificate of Insurance as added to the Policy.

You must take reasonable steps to secure Your Vehicle during the Lay Up Period.

If You would like to use Your Vehicle during the Lay Up Period:

- You must contact Us to provide Us with details of Your intended use;
- We must agree to remove this optional benefit from Your Policy for the period of Your intended use; and
- You must pay any additional Premium that applies.

Protective Clothing

Available if Your Vehicle is a:



motorcycle.

If Your Protective Clothing suffers loss or damage while in, or is stolen from a secured storage area of, Your Vehicle as part of an incident We have agreed to cover under 'Cover for loss or damage to Your Vehicle', We will pay the reasonable cost of replacing Your Protective Clothing with the same or similar items.

We will:

- pay up to the limit specified on Your Certificate of Insurance for this optional benefit; and
- reduce the amount We pay under this benefit by any amount You have been paid under the 'Personal items' additional benefit in respect of the relevant Protective Clothing.

You must:

- not repair or replace Your lost or damaged Protective Clothing without Our consent;
- pay the cost of replacing Your Protective Clothing upfront and provide Us with a tax invoice or receipt for the replacement Protective Clothing and We will reimburse You; and
- report any theft of Your Protective Clothing to the police and provide Us with the incident number and details of when and where the report was made.

Restoration benefit – off road

Available if Your Vehicle is a:



car; or



motorcycle.

We will cover Your Vehicle and its parts, materials and accessories for loss or damage occurring in the Lay Up Period and during the Period of Insurance caused by Accident in Australia, provided the Accident occurs while Your Vehicle or its parts, materials or accessories (as relevant) are:

- securely stored at the address where Your Vehicle is kept overnight as shown on Your Certificate of Insurance; or
- at a mechanic for restoration.

We will provide cover up to a maximum of the limit specified on Your Certificate of Insurance for this optional benefit.

If We accept Your claim and Your claim is for loss or damage to:

- parts, materials or accessories – We will pay the reasonable costs to repair or replace those parts, materials or accessories; and/or
- Your Vehicle – We will decide whether to repair Your Vehicle, pay You the reasonable cost of repairs as determined by Us or pay You the limit specified on Your Certificate of Insurance for this optional benefit.

We will not cover any loss of or damage to:

- parts, materials or accessories that You have claimed for under the 'Spare parts' additional benefit; or
- Your Vehicle that is covered under the 'Cover for loss or damage to Your Vehicle' section.

Note: This optional benefit is only available if You have added the 'Lay up cover' optional benefit to Your Policy.

7 General exclusions

You are not covered under any section of this Policy:

- for loss, damage or liability:
 - caused by or arising from contamination by chemicals or biological agents except as specifically covered under the 'Methamphetamine contamination' additional benefit;
 - that occurs outside of Australia;
 - that arises from any agreement or contract You or any person covered by this Policy enter into unless You or they would have been liable without the agreement or contract;
 - that is or is caused by or arises from:
 - rust;
 - any type of corrosion; or
 - mould or rot;
 - caused by or arising from pollutants or contaminants that discharge or escape from Your Vehicle or a Substitute Vehicle unless this is caused by a sudden and unexpected incident that is covered under the Policy;
 - caused by or arising from an intentional act by:
 - You;
 - an Authorised Driver;
 - a passenger of Your Vehicle or Substitute Vehicle but this exclusion will not apply to loss or damage to Your Vehicle or the legal liability of You or an Authorised Driver of Your Vehicle if the passenger's intentional act was committed without Your express or implied consent; or
 - any person acting with Your express or implied consent;
 - caused by or arising from any nuclear, radioactive, biological or chemical material;
- and We will not be liable to pay any claim or provide any benefit, to the extent that the provision of such cover, payment of such claim or provision of such benefit would expose Us to any sanction, prohibition or restriction under United Nations resolutions or the trade or economic sanctions, laws or regulations of the European Union, the Commonwealth of Australia, the United Kingdom or the United States of America;
- caused by or arising from the lawful seizure, impoundment, confiscation, nationalisation, destruction or requisition of Your property;
- caused by or arising from an Act of Terrorism or an action taken to control, prevent or suppress, or attempt to control, prevent or suppress, an Act of Terrorism;
- caused by or arising from biological, chemical or nuclear pollution or contamination which results from an Act of Terrorism;
- caused by or arising from war, war-like activities, invasion, acts of a foreign enemy, hostilities, civil war, insurrection, rebellion, revolution, military or usurped power;
- that is covered by any compulsory government insurance scheme, Medicare or workers compensation or other government scheme or arrangement, private medical insurance or another policy to the extent permitted by law.
- for any loss, damage, liability, cost or expense of whatsoever nature directly or indirectly caused by, contributed to by, resulting from, arising out of, or in connection with a Communicable Disease or the fear or threat (whether actual or perceived) of a Communicable Disease.
- for wear and tear, gradual deterioration or depreciation.
- for betterment (for example, for repairs to Your Vehicle that leave it in a better condition than before the incident).
- if any Modifications that We asked You about when You first applied for Your Policy have been fitted to Your Vehicle during the Period of Insurance that You have not notified Us of and We have not agreed to cover.
- while Your Vehicle is on consignment or left with a commercial dealer so they can sell it for You.
- while Your Vehicle or a Substitute Vehicle is being ridden, driven, towed or operated by (or Your Vehicle or Substitute Vehicle is in the charge of) a person who:
 - has more than the legal limit of alcohol or a drug in their system and this has caused or contributed to the loss, damage or liability;
 - is under the influence of alcohol or a drug and this has caused or contributed to the loss, damage or liability;
 - refuses a test to determine alcohol or drug levels including a failure to report to a police station within the legal time frame following an incident that requires a drug or alcohol test; or
 - did not remain at the scene of the incident for the time required by law, or until the police arrived, without any reasonable excuse.

This exclusion will not apply if Your Vehicle or Substitute Vehicle was stolen at the time of the relevant incident and the theft was reported to police.

We will not provide cover under this Policy to the driver or rider of Your Vehicle or Substitute Vehicle and We may seek to recover from that driver or rider.

- while Your Vehicle or a Substitute Vehicle is being ridden, driven, towed or operated by a person who:
 - does not have the licence required by law;
 - is not complying with all of the terms and conditions of their licence; or
 - is disqualified from driving or riding, or holds a cancelled or suspended licence.

This exclusion will not apply if Your Vehicle or Substitute Vehicle was stolen at the time of the relevant incident and the theft was reported to police or You could not reasonably have known that the person riding, driving, towing or operating Your Vehicle or Substitute Vehicle did not hold the licence required by law.

We will not provide cover under this Policy to the driver or rider of Your Vehicle or Substitute Vehicle and We may seek to recover from that driver or rider.

- while Your Vehicle or a Substitute Vehicle is being used:
 - for an illegal purpose or in an illegal manner, to the extent that the use of Your Vehicle or a Substitute Vehicle caused or contributed to the loss, damage or liability; or
 - to illegally carry or store explosives, flammable or combustible substances or liquids.

This exclusion will not apply if Your Vehicle or Substitute Vehicle was stolen at the time of the relevant incident and the theft was reported to police.

- if Your Vehicle or a Substitute Vehicle is:
 - in an unsafe condition that caused or contributed to the loss, damage or liability and You knew or should have known that it was unsafe to use;
 - damaged in an incident and You do not take reasonable steps to prevent further loss or damage including if it is stolen and then found, and You have been told where it is;
 - not in good order or repair that caused or contributed to the loss, damage or liability because You knew or should have known it has any unrepaired damage or has rust, mechanical or any other damage that make it unsafe to drive; or
 - not in a condition that meets the registration requirements in the State or Territory in which it is located.
- while Your Vehicle or a Substitute Vehicle is being used:
 - for any business, trade or profession, other than for special occasion or wedding hire;
 - in a race, rally, trial, test, contest, driver or rider training, track day or any kind of motor sport;
 - in a track day, drive day or similar organised event;
 - for hire, rental or peer to peer sharing, other than for special occasion or wedding hire;

- for ridesharing services;
- for food delivery services;
- outside of Australia;
- off-road except as specifically intended by the manufacturer;
- to tow any vehicle or item for financial gain or reward;
- for courier or delivery services or carrying any goods for financial gain or reward;
- for any farming activities;
- for taxi or people transportation services, other than for special occasion or wedding hire;
- in or for any professional motor sport;
- for driving or riding instruction for financial gain or reward;
- for any trade; or
- in a manner that is not compliant with any requirements that apply to it by reason of its Club Plate Registration, to the extent that the use of Your Vehicle or a Substitute Vehicle caused or contributed to the loss, damage or liability.

- while Your Vehicle or a Substitute Vehicle:
 - is being driven by You or an Authorised Driver in a willful, reckless or unsafe manner;
 - or anything Your Vehicle or a Substitute Vehicle is towing:
 - is in an unsafe condition;
 - is unregistered if the law requires it to be registered;
 - is being towed illegally; or
 - exceeds the number of passengers or load limits recommended by the manufacturer.

This exclusion will only apply to the extent that any of these conditions or events caused or contributed to the loss, damage or liability.

This exclusion will not apply if Your Vehicle or Substitute Vehicle was stolen at the time of the relevant incident and the theft was reported to police.

- while a passenger in Your Vehicle or Substitute Vehicle is being willful, reckless or unsafe.

This exclusion will not apply:

- if Your Vehicle or Substitute Vehicle was stolen at the time of the relevant incident and the theft was reported to police; or
- to loss or damage to Your Vehicle or the legal liability of You or an Authorised Driver of Your Vehicle if the passenger's intentional act was committed without Your express or implied consent.
- for mechanical, structural, electrical, hydraulic or electronic breakdown or failure.
- for loss of electronic data unless caused by an incident which We have agreed to cover under this Policy.

- for consequential loss or any loss that You or anyone else may suffer because You cannot use Your Vehicle for any reason (unless specifically covered under this Policy) including but not limited to loss of wages or commission.
- for any reduced value or depreciation of Your Vehicle.
- for loss or damage caused by or arising from You:
 - not taking reasonable care to secure Your Vehicle; or
 - leaving Your Vehicle in an unsafe location after it:
 - breaks down;
 - suffers loss or damage; or
 - is stolen and then found.
- for:
 - loss or damage that occurred, or liability that was incurred, outside the Period of Insurance;
 - the cost to fix previous damage; or
 - loss, damage or liability caused by or arising from previous damage.
- for the cost to fix:
 - faulty design;
 - faulty workmanship by You or someone else We did not authorise; or
 - repairs by You or someone else We did not authorise, except as specifically covered under the 'Lifetime repair guarantee' additional benefit.
- for loss or damage to tyres caused by road cuts, punctures, bursting or braking (except if there is loss or damage to other parts of Your Vehicle).
- for any loss or damage to Your Vehicle (including damage to Your Vehicle's engine or fuel system) caused by the incorrect or incompatible type of fuel being used in Your Vehicle except as specifically provided in the 'Incorrect fuel' additional benefit.
- obtain:
 - the full name, residential address and contact telephone number of all drivers and riders involved in an incident; and
 - the make, model, registration number and insurance details for all vehicles involved in an incident;
- be truthful and frank in any statement You make in connection with a claim;
- keep all damaged property so We can inspect it within a reasonable period of time, if required;
- co-operate fully with Us, even if We have already paid Your claim, which includes:
 - providing Us with all the information, documents and help We need to deal with Your claim;
 - as soon as reasonably possible, sending Us any communications that You receive about any incident (for example, emails, letters, notices or court documents);
 - being interviewed by Us or Our representatives and providing statements;
 - attending court to give evidence; and
 - all Authorised Drivers and passengers in or on Your Vehicle providing Us with all information, documents and help We need to deal with a claim;
- not pay, promise to pay or admit responsibility for a claim or an incident;
- not repair or replace any damaged property without Our consent; and
- give Us Your rights to claim from anyone else. If You have a right to claim from anyone else for an incident covered by Us, You give Us Your rights to make that claim, to conduct, defend or settle any legal action and to act in Your name and You must give Us all information and co-operation that We require. You must not do anything that prevents Us from doing this.

When We make a request for information, documentation, cooperation or assistance from You, any Authorised Drivers or passengers, We will only make a request that is relevant to Our assessment and conduct of Your claim and provide an explanation as to why it is needed. For example, a copy of Your Vehicle registration certificate as proof of ownership.

If You do not meet Your responsibilities, We may refuse or reduce a claim, cancel Your Policy, or do both. The course of action We take when You fail to meet Your responsibilities will be considered in each circumstance based on the impact or effect Your failure to meet Your responsibilities caused or contributed to the claim and Our decision to maintain Your Policy.

You should contact Us to lodge a claim as soon as possible. We can give You immediate assistance with Your claim 24 hours a day, 7 days a week. We:

- can arrange towing for Your Vehicle after an incident;
- may need to inspect Your Vehicle and arrange quotations from any repairer or supplier; and

8 Claims

This section provides information about Our claims process and what We pay when You make a claim. It also includes some examples of how We pay claims including liability claims.

What You must do

When You make a claim, or if something happens that may result in You making a claim, You must:

- stop if anyone is injured or any other vehicle or property is damaged;
- take safe and reasonable steps to prevent any further loss, damage or liability;
- inform the police as soon as possible if anyone is injured or if Your Vehicle is lost, stolen, vandalised or maliciously damaged and provide Us with the incident number and details of when and where the report was made;

- may ask You to substantiate Your claim by providing Us with proof of ownership of Your Vehicle and any other items You claim for under this Policy. For example, We may request a copy of Your Vehicle registration documents as proof of ownership.

How We settle Your claim

If a person We cover makes a claim under ‘Cover for liability’ and We accept that claim, We will:

- act for them or arrange for a lawyer to represent them;
- attempt to resolve the claim; and
- defend the claim in a court or tribunal.

We will decide whether to defend or resolve a claim and how much to pay to resolve a claim.

If We accept Your claim under ‘Cover for loss or damage to Your Vehicle’, We will:

- decide whether to repair Your Vehicle, pay You the reasonable cost of repairs as determined by Us or pay You the Agreed Value that applies to Your Vehicle;
- pay for any additional benefits that You are entitled to;
- pay for any optional benefits that You are entitled to; and
- deduct any amounts that apply to Your Policy and claim (for example, Excess, unpaid Premium, unused registration and compulsory third party insurance premium).

We can choose to settle Your claim through any of the following ways:

- We can choose to repair Your Vehicle. See ‘Repairing Your Vehicle’ for what happens when We decide to repair Your Vehicle.
- We can choose to pay You the reasonable cost to repair Your Vehicle as determined by Us. We determine the reasonable cost to repair the damage by looking at a range of factors including quotes from Your own repairer, quotes from other repairers, Our nominated repair methods for the type of damage to Your Vehicle and reports from Our assessors. See ‘Repairing Your Vehicle’ for what happens when We decide to pay You the cost to repair Your Vehicle.
- We can choose to pay Your claim as a Total Loss. We will do this when We determine Your Vehicle is a Total Loss or when We decide to. If We do this then Your Policy ends and You will not get a refund of Your Premium. See ‘Total Loss of Your Vehicle’ for what happens if We decide to pay Your claim as a Total Loss.
- We can choose to pay for additional and/or optional benefits. If We agree to pay You any additional benefits or optional benefits, We will choose the method of settlement and repairer or supplier. If We settle a claim for damaged property by replacing it or paying You the cost of replacing it, the damaged property becomes Ours unless We let You keep it.

Our choice will have regard to the circumstances of Your claim and consider any preference You may have.

The maximum amount We will pay for a claim under ‘Cover for loss or damage to Your Vehicle’ is the Agreed Value of Your Vehicle and any benefits You are entitled to.

Repairing Your Vehicle

If We choose to settle Your claim by repairing Your Vehicle:

- We decide the best way to repair the damage; and
- We will arrange for a repairer to fix Your Vehicle.

Choosing a repairer

If We arrange for a repairer to fix Your Vehicle, We will:

- help find a repairer most convenient to You;
- choose the most suitable repair method for the type of damage to Your Vehicle;
- manage the whole repair process on Your behalf;
- arrange for part of the repair to be carried out by a specialist service provider if required; and
- seek Your agreement to any repairs if the repairs to Your Vehicle leave it in a better condition than before the incident and We need to seek a contribution from You for the additional amount which represents the betterment.

If We decide to authorise and pay for the reasonable cost to repair Your Vehicle, We will tell You if You need to pay the Excess to Us, the repairer or another supplier.

We are not responsible for making sure the repairer can complete the repairs when it suits You and We will not cover:

- any additional costs that may result if the repairer appointed or engaged by You is delayed or has problems getting parts; or
- any repairs not authorised by Us.

If We authorise and pay for a repairer to fix Your Vehicle, then We will provide a lifetime guarantee for the workmanship of those repairs as long as You are the owner of Your Vehicle. See the ‘Lifetime repair guarantee’ additional benefit.

Inspections

If We ask, You must allow Us to inspect Your Vehicle at a reasonable time and place and We will:

- tell You where You need to take Your Vehicle; or
- arrange for Your Vehicle to be towed to a repairer or other place We choose.

Paying the reasonable cost to repair Your Vehicle

If We decide to pay You the reasonable cost to repair Your Vehicle as determined by Us, We will deduct the following from the amount We pay You:

- the Excess; and
- any input tax credit You are entitled to under *A New Tax System (Goods and Services Tax) Act 1999* (Cth).

Parts used to repair Your Vehicle

Generally We use the following parts to repair Your Vehicle. If Your Vehicle is:

- less than 3 years from the date it was first registered, We use new Genuine Parts when reasonably available; and
- 3 years from the date it was first registered or older, We use new Genuine Parts when reasonably available or quality non-mechanical reusable parts.

Regardless of the age of Your Vehicle, We may use parts that are not Genuine Parts to replace Your windscreen, window glass, sun roof, moonroof, radiator or air-conditioning components.

We will only use quality non-mechanical reusable parts when it:

- is consistent with the age and condition of Your Vehicle;
- does not affect the safety or the structural integrity of Your Vehicle;
- complies with Your Vehicle manufacturer’s specifications and applicable Australia Design Rules;
- does not adversely affect the way Your Vehicle looks after it has been repaired; and
- does not void or affect the warranty provided by the manufacturer of Your Vehicle.

Unrepaired damage

If Your Vehicle had any unrepaired damage before an incident for which We agree to provide cover, You must contribute to the repair costs if the unrepaired damage results in Us having to repair more areas of Your Vehicle than were affected by the incident or We needed to replace. For example, a panel of Your Vehicle was only partly damaged in an incident We have agreed to cover and can be repaired. The repairer notices that the panel has unrepaired hail damage. If there wasn’t any hail damage We would only need to repair the damaged area of the panel. However, because of the unrepaired hail damage to the panel We must replace the whole panel. In this case We would seek Your agreement to any repairs and ask You to contribute to the costs of the repairs.

Undamaged areas

We don’t repair undamaged areas of Your Vehicle to create a uniform appearance. If You wish to have additional repairs completed to undamaged areas – for example to ensure a uniform appearance, You may pay to do so or We will consider within the context of how best to settle Your claim – for example deducting costs or making an allowance for betterment.

Motor Vehicle Insurance and Repair Industry Code of Conduct

This Code aims to promote transparent, informed, effective and co-operative relationships between smash repairers and insurance companies based on mutual respect and open communication. We support the Code and are committed to continually reviewing Our operations to make sure We comply with it.

Total Loss of Your Vehicle

If We accept Your claim and determine Your Vehicle is a Total Loss, We will pay You the Agreed Value (as shown on Your Certificate of Insurance) after deducting:

- the Excess;
- any unpaid Premium;
- any input tax credit You are entitled to under A New Tax System (Goods and Services Tax) Act 1999 (Cth); and
- the unused portions of registration and compulsory third party insurance (if applicable).

We will tell You who to pay these amounts to.

After We settle Your claim for a Total Loss Your Policy comes to an end and no refund of Your Premium is due.

Salvage rights

If Your Vehicle is 35 years old or less at the time of the incident any salvage of Your Vehicle will become Our property. However, We will provide You with the first option to purchase the salvage of Your Vehicle at a fair price.

If Your Vehicle is more than 35 years old at the time of the incident We will let You keep Your damaged Vehicle at no cost.

Excess

As part of the finalisation of Your claim, You must pay the Excess that applies. An Excess is an amount You contribute towards the cost of a claim. Your Certificate of Insurance shows the amount and types of Excess that apply to Your Policy. You may need to pay more than one Excess.

The type of Excess You need to pay depends on what Your claim relates to and who was driving or riding Your Vehicle.

The following Excesses may apply to Your Policy:

Vehicle	applies to most claims under the Policy;
if Your Vehicle is a car:	
Driver	applies in addition to the Vehicle Excess when a person specified with a Driver Excess on the Certificate of Insurance is driving Your Vehicle;
Undisclosed Driver	applies in addition to the Vehicle Excess when a person 25 years of age or older who is not listed as a driver on the Certificate of Insurance is driving Your Vehicle; and
Undisclosed Driver Age	applies in addition to the Vehicle Excess when a person less than 25 years of age who is not listed as a driver on the Certificate of Insurance is driving Your Vehicle; and
if Your Vehicle is a motorcycle:	
Rider	applies in addition to the Vehicle Excess when a person specified with a Rider Excess on the Certificate of Insurance is riding Your Vehicle;
Undisclosed Rider	applies in addition to the Vehicle Excess when a person 25 years of age or older who is not listed as a rider on the Certificate of Insurance is riding Your Vehicle; and

Undisclosed Rider Age	applies in addition to the Vehicle Excess when a person less than 25 years of age who is not listed as a rider on the Certificate of Insurance is riding Your Vehicle.
-----------------------	--

We only accept a claim if the total amount You are claiming is more than any Excesses that apply to Your claim.

You must pay any Excess that applies to Us or a repairer or supplier. We may deduct it from what We pay You or We will tell You who to pay the Excess to. If We request You pay the Excess, We will tell You who to pay and may require payment as part of finalising Your claim.

There are circumstances when You do not need to pay one or more Excesses.

Other deductions

If We pay Your claim as a Total Loss, We will deduct other amounts to settle Your claim.

Unpaid Premium

Before We pay Your claim We will deduct:

- any Premium amount for the Policy that is due but has not been paid; and
- if You pay Your Premium by instalments, the instalments that cover the rest of Your Period of Insurance.

Unused registration and compulsory third party insurance

The amount You pay to register Your Vehicle or for any compulsory third party insurance forms part of Your Vehicle value. If We pay Your claim We will deduct any unused registration costs and compulsory third party insurance.

To get a refund for these amounts You will need to contact Your:

- relevant motor registration authority; and
- compulsory third party insurer if Your Vehicle is registered in New South Wales.

Credit provider's rights

You must tell Us if You have used all or part of Your Vehicle as security for a loan with a credit provider. Your credit provider may be a bank, credit union or other type of lender. This may also apply if You lease or have a hire purchase agreement on Your Vehicle.

We list Your credit provider as an interested party on Your Certificate of Insurance.

When You have a credit provider noted on Your Certificate of Insurance We:

- treat Your Vehicle as being under a finance arrangement;
- treat any statement, act, omission or claim by You as a statement, act, omission or claim by the credit provider; and
- may recover any payment either in Your name or the credit provider's name.

Payments to the credit provider

If We decide to pay You for a claim on Your Vehicle that is under a finance arrangement, We will first pay the credit provider the lower of these amounts after deducting any Excess and other deductions that apply:

- the Agreed Value as shown on Your Certificate of Insurance;
- the cost of repairing Your Vehicle; or
- the balance owing to the credit provider under the finance arrangement.

However, We will only pay the credit provider if they:

- are listed on Your Certificate of Insurance; and
- give Us any help We ask for.

If We make a payment to a credit provider, then that payment discharges Our obligation to You under Your Policy for the amount paid.

If We decide to settle Your claim as a Total Loss, then before We settle Your claim:

- We will check the Personal Property Securities Register to confirm whether any money is owing on Your Vehicle; and
- If there is any outstanding amount owing under any finance arrangement, You will be required to provide reasonable assistance to enable Us to resolve those financial arrangements and settle Your claim.

GST

If We pay Your claim, We will deduct an amount equal to Your input tax credit entitlement. This applies to any amount We pay, including where We state that an amount will include GST. Any payment We make to settle Your claim will be considered to be made in full even if We have reduced the amount We pay as set out in this section.

Recovery actions

You agree that the following provisions under 'Recovery action by Us' and 'Recovery action by You' apply where We cover You under this Policy for some or all of the loss or damage You suffer in connection with an incident.

Recovery action by Us

You agree We may take steps to recover from someone else We consider responsible for the incident:

- some or all of the loss or damage We cover; and/or

- some or all of the loss or damage We do not cover, whether or not it is covered by another insurer or You do not have cover for it.

You agree that We may take such recovery action:

- without Your specific consent;
- using Your name; and
- whether or not You have been, or have a right to be, fully compensated for all of Your loss or damage by Us or anyone else.

You also agree that:

- We have the right to decide upon the conduct and any settlement of any recovery action We take;
- We may exercise all the rights You have in connection with the loss or damage You have suffered in connection with the incident;
- of any amount recovered in a recovery action We take:
 - We keep the amount We have paid, or must pay, You under the Policy plus any interest recovered on that amount and any administrative, recovery agent, funding and legal costs We have incurred in taking the recovery action; and
 - We will then pay You the amount of loss or damage You have suffered in connection with the incident for which You do not have any cover with Us plus any interest recovered on that amount and costs You may have been required by Us to contribute; and
 - We will keep any remaining balance;
- You must give Us all the information and co-operation that We require to take the recovery action. When We make a request for information or cooperation from You, We will only make a request that is relevant to Our recovery action and provide an explanation as to why it is needed; and
- You must not do anything which prejudices Us in taking any recovery action including that You must not:
 - assign Your rights to anyone else without Our consent; or
 - opt-out of any representative or group proceedings taken by Us.

Recovery action by You

You agree that You may only take recovery action with Our prior written consent and on conditions which We in Our discretion impose. We will not unreasonably withhold Our consent.

You also agree:

- You must have proper regard for Our interests in respect of loss or damage that We cover;
- You must seek to recover the loss or damage We cover in addition to any other loss or damage You have suffered in connection with the incident;
- of any amount recovered in a recovery action You take:

- You keep the amount of loss or damage You have suffered in connection with the incident for which You do not have any cover with Us plus any interest recovered on that amount and any administrative and legal costs You have incurred in taking the recovery action; and
- You will then pay Us the amount We have paid, or must pay, You under the Policy plus any interest recovered on that amount; and
- You will keep or pay any remaining balance in accordance with any other obligations You have;
- We may take over the conduct of any legal proceedings started by You or on Your behalf, including where You are an applicant or plaintiff, or a group member, in representative or group proceedings; and
- We may require You to cease recovery action that You have commenced.

How We pay claims – some examples

The following examples are designed to show how a claim payment might be calculated and what amount You may be required to pay. These are examples only, do not cover all scenarios or benefits and do not form part of the Policy terms and conditions.

Claim example 1 – Repairing Your Vehicle

Your Certificate of Insurance shows:

- Your Vehicle is insured with an Agreed Value of \$25,000;
- You have not chosen any optional benefits under Your Policy; and
- a Vehicle Excess of \$750, Undisclosed Driver Excess of \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

You are driving Your Vehicle and have a crash with another vehicle where You are at-fault. Your Vehicle is undrivable and You contact Us and We arrange for Your Vehicle to be towed from the location of the accident to a repairer.

The towing cost is \$350.

We assess the cost to repair Your Vehicle to be \$2,250.

You wish to hire a vehicle for 6 days while Your Vehicle is being repaired at a cost of \$60 per day.

We accept Your claim under the Policy and pay \$350 to the towing company and pay the repairer \$1,500 (being the cost of repairs of \$2,250 less the \$750 Vehicle Excess).

You must pay the repairer the Vehicle Excess of \$750. We do not pay for Your hire vehicle as You did not take the 'Hire vehicle or alternative transport after incident' optional benefit.

Claim example 2 – Total Loss

Your Certificate of Insurance shows:

- Your 40 year old Vehicle is insured with an Agreed Value of \$14,700;
- You have not chosen any optional benefits under Your Policy; and
- a Vehicle Excess of \$750, Driver Excess of \$500 applies to Your 22 year old son, Undisclosed Driver Excess \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

You pay Your Premium by monthly instalments of \$55.

Your 22 year old son is driving Your Vehicle and has a crash with another vehicle where he is at-fault. Your Vehicle is undrivable and You contact Us and We arrange for Your Vehicle to be towed from the location of the accident to a repairer.

The towing cost is \$300.

We assess Your Vehicle to be a Total Loss.

Your Policy has 4 months unpaid Premium instalments before the end of the Period of Insurance and Your Vehicle has \$250 of unused registration and compulsory third party insurance premium.

We accept Your claim under the Policy and We pay the towing company \$300 and pay You \$12,980 calculated as:

Agreed Value of	\$14,700
less Vehicle Excess of	-\$ 750
less Driver Excess of	-\$ 500
less unused registration and compulsory third party insurance premium of	-\$ 250
less remaining unpaid monthly instalments of	-\$ 220
TOTAL	\$12,980

You arrange a refund of Your unused registration and compulsory third party insurance of \$250. Your Policy ends and as Your Vehicle is over 35 years old You keep Your Vehicle at no cost.

Claim example 3 – Vehicle stolen

Your Certificate of Insurance shows:

- Your Vehicle is insured with an Agreed Value of \$32,000;
- You have not chosen any optional benefits under Your Policy; and
- a Vehicle Excess of \$800, Undisclosed Driver Excess of \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

Your Vehicle is stolen and not recovered.

We accept Your claim under the Policy and We determine Your Vehicle to be a Total Loss.

You have paid Your Premium for the Period of Insurance annually. Your Vehicle has \$180 of unused registration and compulsory third party insurance premium.

We pay you \$31,020 calculated as:

Agreed Value of	\$32,000
less Vehicle Excess of	-\$ 800
less unused registration and compulsory third party insurance premium of	-\$ 180
TOTAL	\$31,020

You arrange a refund of Your unused registration and compulsory third party insurance of \$180. Your Policy ends.

Claim example 4 – Liability claim for damage to someone else's property

Your Certificate of Insurance shows:

- Your Liability Limit is \$20,000,000; and
- a Vehicle Excess of \$800, Undisclosed Driver Excess of \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

You lose control of Your Vehicle and crash into someone's front fence and garden.

We accept Your claim under the Policy and arrange lawyers to act on Your behalf in relation to the homeowner's claim against You. A court decides You are liable to pay \$8,000 for the claim made against You by the homeowner.

We pay the homeowner \$8,000. We also pay Our lawyers \$1,500 being their fees to act on Your behalf in the court proceedings. You need to pay Us the Vehicle Excess of \$800.

Claim example 5 – Crash with at-fault driver

Your Certificate of Insurance shows:

- You have not chosen any optional benefits under Your Policy; and
- a Vehicle Excess of \$800, Undisclosed Driver Excess of \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

You are driving Your Vehicle and have a crash with another vehicle that is (and the driver is) uninsured. You provide Us with the registration details of the other vehicle and the driver's name and address. We determine that the driver of the other vehicle is solely at-fault for the crash and agree to accept Your claim under the Policy.

We assess the cost to repair Your Vehicle to be \$4,500. The Agreed Value of Your Vehicle is \$8,500.

We pay the repairer \$4,500. You do not need to pay any Excess.

Claim example 6 – Excess greater than claim amount

Your Certificate of Insurance shows:

- Your Vehicle is insured with an Agreed Value of \$32,000;
- You have not chosen any optional benefits under Your Policy; and
- a Vehicle Excess of \$800, Undisclosed Driver Excess of \$400 and Undisclosed Driver Age Excess of \$550 apply to Your Policy.

You Accidentally reverse Your Vehicle into a fence at Your home and damage the rear of Your Vehicle.

We assess the cost to repair Your Vehicle to be \$500. As Your Vehicle Excess is \$800, We stop processing Your claim and do not pay anything under Your Policy as the applicable Excess is more than the repair costs for the damage to Your Vehicle.
