

NSW CTP Notice of Policy Cancellation

If your registration has been finalised by attending Transport for NSW / Service NSW call 132 132 between 9am and 5pm Mon to Fri to finalise your CTP over the phone. Alternatively; This cancellation form is required when

- You have purchased a NSW registered vehicle and have re-registered your vehicle interstate (plates have been surrendered Interstate) or
- You have been instructed to by our CTP Cancellations
 Department or
- as a preference to cancelling via the phone

Please Note: If you have sold the vehicle registered, both the registration and CTP will be transferred to the new owner and therefore there will be no refund due.

Full Refund

An unused policy can only be cancelled when it can no longer be used for the registration of a vehicle. This occurs when one of the following has occurred:

The registration has been cancelled and registration plates have been surrendered to Transport for NSW / Service NSW

The vehicle has been registered using a different CTP Green Slip

The CTP Green Slip 'certificate use by date' has expired

The CTP Green Slip 'certificate use by date' has not expired. For this option, please email **ctpaccountspayable@iag.com.au** and provide the reason for cancellation and any supporting material which confirms that the CTP Certificate cannot or will not be used

Midterm Refund

The refund for a policy that has been used for registration, can only be processed once you have attended Transport for NSW / Service NSW and cancelled your registration.

Ensure the Transport for NSW / Service NSW "Confirmation of Cancelled Registration" letter is attached.

If the vehicle has been re-registered interstate, registry or your new interstate registration papers.
